## Submission \& Disposition of License Application

All applications for licenses to sell alcoholic liquor at retail as authorized by this chapter shall be submitted to the County Clerk by filing in the Office of the County Clerk. The applicable filing fee shall be paid when initial application is filed. The fee shall be separate from all other fees set forth in this Code. All such applications shall be filed in duplicate in the office of the County Clerk and shall be accompanied by the deposit of a certified cashier's check, a money order, or cash in the full amount of the license fee required to be paid for the amount of the license fee required to be paid for the kind of license applied for, which fee shall be returned to the applicant if such application is denied. The original of said application shall remain in the office of the County Clerk as a permanent record. The County Clerk shall forthwith deliver a copy of said application together with all attachments to the Marshall County Sheriff, who shall then cause a thorough investigation to be made into the fitness and eligibility of the applicant for a license.

Within thirty (30) days of the receipt of the application by the Marshall County Sheriff, he shall report to the Chairman of the Marshall County Board the results of his investigation along with his recommendation whether the applicant should be granted or denied or held for further investigation including the reasons for such recommendation.

Within ten (10) days of the receipt of the investigation report, and recommendation of the Marshall County Sheriff, the Chairman of the Marshall County Board shall notify the applicant that his application is granted, denied or held for further investigation. The period of such additional investigation shall not exceed an additional thirty (30) days unless additional investigation, the Chairman of the Marshall County Board shall advise the applicant in writing whether the application is granted or denied.

Whenever an application is denied or held for further investigation, the Chairman of the Marshall County Board shall advise the applicant of the reasons for such action.
