## MARSHALL COUNTY BOARD MEETING June 14, 2018

The Marshall County Board met in the Marshall County Board Room for the June Board meeting on June 14, 2018 at 8:30 a.m. Chairman Kroeschen, called the meeting to order. Following the Pledge of Allegiance, roll call shows: Bakewell, Johnson, McGrath, Minnick, Stash, Waldschmidt Lindstrom and Kroeschen. Gauwitz and McLaughlin were absent.

Moment of silence was held in remembrance of Charlie Allen.

Pat Murphy whom is on the Marshall County Airport Board stated that they held a meeting Tuesday, June 12<sup>th</sup> and he stated that Charlie did a lot for the Airport and the community. It will be big shoes to fill. The Airport Board discussed on what options they should do for a memorial. They are going to discuss at their next meeting and get the community input. The Airport Board made a recommendation to the Marshall County Board to appoint Ron Kenyon who is currently a pilot and flies at the Airport.

County Engineer Pat Sloan gave an update on Zoning. They will be having another ZBA meeting on Thursday, June 21<sup>st</sup> at 7:00 p.m. for the Minonk Stewardship Wind LLC for a meteorological tower. Sloan reported that he would email out the list of building permits.
