## MARSHALL COUNTY BOARD MEETING August 9, 2018

The Marshall County Board met in the Marshall County Board Room for the August Board meeting on August 9, 2018 at 8:30 a.m. Chairman Kroeschen, called the meeting to order. Following the Pledge of Allegiance, roll call shows: Kroeschen, Daykin, Gauwitz, Johnson, McGrath, McLaughlin, Minnick, Stash, Waldschmidt.

Bakewell, Lindstrom and McGlasson were absent.

It was moved by Stash and seconded by Gauwitz to **approve the minutes** for 7/12/18 as presented. Vote shows: all ayes, 0 nays, 3 absent, motion carried.

County Engineer Pat Sloan report that the ZBA had three public hearings on July 19<sup>th</sup>. All three of the applications are 2 MW community solar projects. Robert and Jill Conrad were present at the meeting and expressed their concerns with the Sparland Solar tower being right in front of their home. John Moreland who is a member of the Sparland Baptist Church gave an overview of what was presented at their church council meeting. He also stated that he was under the impression that the property would someday be used for a subdivision. Jon Carson and Colleen Callahan from Trajectory Energy Partners, LLC were present as well and went over the handout that was given to each member and answered various questions. Pat Sloan also gave each member a copy of the minutes from the ZBA hearings. The ZBA voted 5-0 on all three special use and variance petitions to recommend approval by the County Board. Sloan also reported that there would be no ZBA meeting required this month.

**#18-75** It was moved by Gauwitz and seconded by McLaughlin to **Approve** the Intergovernmental Agreement-Marshall-Putnam Counties County Engineer Services. Vote shows: all ayes, 0 nays, and 3 absent.

County Engineer Pat Sloan also reported on Highway that they have completed the crack filling for the year. They had two international trucks that broke down and one had to be towed. The South La Rose Road is near completion. The paving, guard rails and seeding need to be completed. A summary of the 2017 construction projects were handed out. Sloan thanked County Clerk Jill Piper for helping with submitting a grant for Western Road Realignment Project on the GATA portal.

Diana Rawlings from the Health Department was present and went over the annual report.
