Thank you for your continued support and participation with NCICG.

Your membership enabled us to accomplish several things in the past year. Listed below are just a few:

- Five (5) of our local communities have secured a total of \$1.7 million for public infrastructure projects from the 2016 Illinois Community Development Block Grant (CDBG) Public Infrastructure Program.
- Our second semi-annual meeting was held May 10th with presentations from State Treasurer Michael Frerichs' office and Bureau/Putnam County Community Partners Against Substance Abuse (CPASA).
- Two (2) of our local communities have received a total of \$80,000 from Illinois Housing Development Authority (IHDA) through their Abandoned Properties Program to assist the communities in demolishing abandoned homes.
- Four (4) of our local communities have secured a total of \$3.4 million in Pre Disaster Mitigation funds from the Federal Emergency Management Agency (FEMA) for flood protection projects.
- Developed and began implementing a strategic plan for the North Central Illinois Council of Governments.
- Two (2) of our local communities have received a total of \$194,145 for transportation enhancements from the Illinois Transportation Enhancement Program (ITEP).

We are proud of what we have accomplished and couldn't have done it without you!
