## MARSHALL COUNTY BOARD MEETING November 8, 2018

The Marshall County Board met in the Marshall County Board Room for the November Board meeting on November 8, 2018 at 8:30 a.m. Chairman Kroeschen, called the meeting to order. Following the Pledge of Allegiance, roll call shows: Kroeschen, McGlasson, Lindstrom, Waldschmidt, Minnick, McGrath, Johnson, McLaughlin, Gauwitz, Daykin and Bakewell present. Stash was absent.

Chairman Kroeschen wanted to thank Vicki Waldschmidt and Sue McGrath for their service on the County Board.

Chairman Kroeschen also wanted to thank Sheriff Rob Russell for all his service and commitment as serving as Sheriff in Marshall County. Sheriff Russell thanked everyone and stated it's been a pleasure working with everyone on the County Board.

It was moved by Bakewell and seconded by McLaughlin to **approve the minutes** for 10/11/18 as presented. Vote shows: all ayes, 0 nays, 1 absent, motion carried.

County Engineer Pat Sloan reported on Zoning. The ZBA had three public hearings on October 18<sup>th</sup>. to consider three community solar projects from IPS Solar. The ZBA recommends approval of the Palm and Schulte/Weide project. The Ratcliff project has conditions and failed to receive recommendation. IPS contacted County Engineer Pat Sloan and withdrew Ratcliff project from consideration. Sloan reported that the next ZBA meeting will be November 15<sup>th</sup> for a special use permit.

Chairman Kroeschen thanked the Board for making a motion on the projects.

County Engineer reported on Highway. He stated he has been finishing construction paper work from all the construction. Steuben bridge project will get seal coated next year and the total project cost was \$616,000.00

County Engineer reported on recycling. The Fall Collection day was a very successful event. 30% came from Putnam County and 70% came from Marshall County. They had two semi loads.

Finance Chairman Bakewell reported on the 2018 Tax Levy. He stated that the biggest change was on ECHO down 16% from the previous year. The total budget is \$3,059,709.00. In the spring we will know if our extra payment helped and how much.
