RESOLUTION AUTHORIZING THE COLLECTION OF A FEE FOR THE OPERATION AND ADMINISTRATION OF THE CHILD ADVOCACY CENTER

WHEREAS, Braveheart, Children Advocacy Center of Henry County, has a satellite location in Marshall County and provides services to Marshall County residents under the age of eighteen who are victims of sexual or physical abuse and their non-offending family members; and

WHEREAS, 55 ILCS 5/5-1101(f-5) permits the County of Marshall to enact a resolution adopting a mandatory fee between \$5 and \$30 be paid by the defendant on a judgment of guilty or a grant of court supervision for a felony, misdemeanor, petty offense and business offense.

NOW, THEREFORE BE IT RESOLVED, by the County Board of Marshall County, Illinois that the Clerk of the Circuit Court of Marshall County be hereby authorized to collect the fee of \$15 to be paid by a defendant on a judgment of guilty for a felony offense and a fee of \$10.00 to be paid by a defendant on a judgment of guilty or a grant of court supervision under Section 5-9-1 of the Unified Code of Corrections for a Class A, Class B, or Class C Misdemeanor and a fee of \$5.00 to be paid by a defendant on a judgment of guilty or a grant of court supervision for petty and business offenses ;

BE IT FURTHER RESOLVED that the Clerk of the Circuit Clerk shall deposit such fees into an account specifically for the operation and administration of the Child Advocacy Center of Henry County;


BE IT FURTHER RESOLVED that the Clerk of the Circuit Court shall remit those fees to the Child Advocacy of Henry County (Braveheart);

BE IT FURTHER RESOLVED that this Resolution shall be effective on November 1, 2015.
