## MARSHALL COUNTY BOARD ORDINANCE

#17-70

WHEREAS, effective June 9, 2000, the provisions of Senate Bill 1582 at 55 ILCS 5/3-5018 amending the Recorder's Imaging Fee, authorized the County Recorder, with the approval from the County Board to establish an additional charge up to \$3.00 for the filing of every instrument, paper, or notice for record; and

WHEREAS, 55 ICLS 5/3-5018 provides that the fees collected shall be deposited into a special fund set up by the Treasurer of the County and such funds collected pursuant to Public Act 83-1321 shall be used for a document storage system to provide the equipment, materials and necessary expenses incurred to help defray the costs of implementing and maintaining such a document record system and for a system to provide electronic access to those records.

WHEREAS, pursuant to 55 ILCS 5/3-5018, allows the County Board to increase the fees allowed in that Section and collect the increased fees from all persons and entities other than officers, agencies, departments and other instrumentalities of the State if the increase is justified by an acceptable cost study showing that the fees allowed in the Section are not sufficient to cover the costs of providing the service, and that any such supporting documents shall be public record and subject to public examination and audit, and;

WHEREAS, the County Board of Marshall County, Illinois, has completed a study of the direct and indirect costs associated with the development and maintenance for microfilm in Marshall County and the conclusion shows that the fee should be increased to cover such costs, and;

WHEREAS, the current fee is \$4.00 and;

WHEREAS, Marshall County has determined that increasing the fee in the amount of \$2.00 is necessary to cover the cost of providing the Microfilm, and that the increase is justified by an acceptable cost study showing the same.

NOW, THEREFORE, BE IT ORDAINED, by the County Board of Marshall County, that effective <u>December 1<sup>st</sup>, 2017</u>, the fees of \$4.00 will be increased by \$2.00 for a total to be charged of \$6.00 for the filing of every instrument, paper, or notice for record; and that such fees collected shall be disbursed according to the law for document storage system.




