# MARSHALL COUNTY BOARD MEETING December 9, 2021

The Marshall County Board met in the Courtroom for the December Board meeting on December 9, 2021, at 8:35 a.m. Vice Chairman McGlasson called the meeting to order. Following the Pledge of Allegiance, roll call shows: Vice Chairman McGlasson, McLaughlin, Minnick, Lindstrom, Stash, Lueders, and Bakewell present.

Chairman Kroeschen, Donna, and Gauwitz were on zoom.

Balensiefen and Meierkord were absent.

It was moved by Lindstom and seconded by Stash to **approve** the minutes as presented. Vote shows: 7 ayes, 0 nays and 5 absent.

No Health Department update as they were not present.

Sloan reported on Zoning. A list of the building permits that were issued for 2021 was gave to each member. ZBA had a hearing for a setback and was approved. The text amendment application is on hold for Spring Bay Land Development. No ZBA meeting next week.

Sloan reported on AKUO. They currently have 33 turbines between Toluca and Minonk. He has been in contact with their contractor. The night lighting needs to be minimized. He stated that the system is not working like it should and its not fully calibrated. They are in violation. He has been sending letters weekly. He stated they need to have this fixed by January 1<sup>st</sup>. or there will be fines. He stated that the lights stay on for 30 minutes. They are continuously on. He stated in the ordinance their fine can be between \$50.00 and \$500.00. He has talked to the Company that is currently doing the work.

**#21-130** It was moved by Stash and seconded by McLaughlin to **approve** County Engineer Pat Sloan to send a certified letter and the maximum fine be \$500 per turbine per incident. Vote shows: 7 ayes, 0 nays and 5 absent.

Sloan also reported he has ordered 2 electronic message boards. He is going to set one up in Lacon about the vaccinations. The other message board will be set up around the County. A list of the construction projects was given to each member he stated that he did over \$1.5 million dollars in projects for 2021. Susie Simmons who is the secretary at the Highway Department is leaving and her last day will be November 19<sup>th</sup>. He will be posting the job description.

**#21-131** It was moved by McLaughlin and seconded by Lindstrom to **approve** resolution for County Aid for Township Drainage Structure.

Vote shows: 7 ayes, 0 nays and 5 absent.

Sloan reported on recycling. He stated that the trailers are getting old and at some point, they will need to get some new trailers. In the bills you will see a repair bill. He also stated they had 31,000 pounds of electronics in November, 22,000 pounds in TV's and for the whole year they collected 74,000 pounds.

Balensiefen arrived at 8:56 A.M.

#### **Old Business:**

**#21-132** It was moved by McLaughlin and seconded by Lueders to **resend the vote from ordinance #21-129 for the redistricting.** 

Vote shows: 8 ayes, 0 nays and 4 absent.

Discussion was held on the redistricting. Vice-Chairman McGlasson stated that this resolution must be passed at this meeting, or a special meeting will have to be held. The Chairman and Vice-Chairman positions are voted on every 2 years. This will not take effect until December of 2022.

Every member will be up for re-election this next election. This resolution also states the terms that will be drawn after the members are elected.

#21-133 It was moved by McLaughlin and seconded by Stash to approve the Redistricting Ordinance as follows: The Board stay at 12 members, \$10,000 Chairman, \$6,000 Vice-Chairman, Building and Grounds Chairman Stipend \$1,000.

**Roll Call Vote:** 4 Yes, 4 No and 4 Absent. (Tied)

#21-134 It was moved by Lindstrom and seconded by Bakewell to approve the Redistricting Ordinance as follows: The Board stay at 12 members, \$7500 Chairman, \$4,500 Vice-Chairman, Each Member \$3,000 and Building and Grounds Chairman Stipend \$750.00.

Roll Call Vote: 5 Yes, 3 No and 4 Absent. (Passed)

#### **New Business:**

#21-135 It was moved by Minnick and seconded by McLaughlin to approve the re-appointment of Wayne Strawn II to the ETSB Board for 3-Year Term.

Vote shows: 8 ayes, 0 nays and 4 absent.

**#21-136** It was moved by Stash and seconded by Lindstrom to **approve** the re-appointment of Marty McLaughlin to the ETSB Board for a 3-Year Term.

Vote shows: 8 ayes, 0 nays and 4 absent.

911 Coordinator was present and explained that they need more coverage in the dead spots where there is no communication. The 2 problem spots are on Rt 26 and by Village of Hopewell on Rt 29.

#21-137 It was moved by McLaughlin and seconded by Lueders to approve the request from the 911 Coordinator of \$30,000 funds to be paid by the American Rescue Grant Funds. Vote shows: 8 ayes, 0 nays and 4 absent.

Circuit Clerk Gina Noe was present on zoom and explained it's to be done by statue and the current resolution is \$21.00 and the new resolution will be for \$20.00.

#21-138 It was moved by McLaughlin and seconded by Minnick to approve the resolution Authorizing County Law Library Fee.

Vote shows: 8 ayes, 0 nays and 4 absent.

#21-139 It was moved by Bakewell and seconded by Balensiefen to approve the Designating Bank Depositories for the County Treasurer.

Vote shows: 8 ayes, 0 navs and 4 absent.

#21-140 It was moved by McLaughlin and seconded by Balensiefen to approve the Budget Amendment for American Rescue Grant Fund.

Vote shows: 8 ayes, 0 nays and 4 absent.

#21-141 It was moved by McLaughlin and seconded by Lueders to approve Budget Amendment for General Fund.

Vote shows: 8 ayes, 0 nays and 4 absent.

#21-142 It was moved by Minnick and seconded by McLaughlin to approve the Budget Amendment for County Motor Fuel Tax Fund and Engineering Revolving Fund. Vote shows: 8 ayes, 0 nays and 4 absent.

#21-143 It was moved by McLaughlin and seconded by Balensiefen to **approve** the Budget Amendment for Court Bailiff.

Vote shows: 8 ayes, 0 nays and 4 absent.

**#21-144** It was moved by Lueders and seconded by McLaughlin to **approve** the Budget Amendment for the Sheriff Department.

**#21-148** It was moved by Bakewell and seconded by McLaughlin to **approve** the Resolution State's Attorney Appellate Prosecutor.

Vote shows: 8 ayes, 0 nays and 4 absent.

**#21-149** It was moved by McLaughlin and seconded by Balensiefen to **approve** the Resolution for the 2022 Dues \$100 Marshall County Historical Society.

Vote shows: 8 ayes, 0 nays and 4 absent.

Vice Chairman McGlasson and County Clerk & Recorder Jill Kenyon gave an update on .GOV The Clerk stated that the website and her email must be switched to .GOV by the next election which is June 28<sup>th</sup>, 2022. This is the new state statue requirement. Vice-Chairman McGlasson stated that we currently have a google account and we need to have safe and secure emails. This will require all board members, department heads and staff and website to switch to .GOV

#21-150 It was moved by Lindstrom and seconded by Balensiefen to approve JANO Technology quote to switch all emails and County Website to .GOV

Vote shows: 8 ayes, 0 nays and 4 absent.

It was moved by Bakewell and seconded by Stash to approve the Payment of the Bills.

**Finance/Budget:** County Clerk & Record Jill Kenyon reported that the Auditors will be here next week.

**County Highway & Recycling:** Lindstrom reported that the guardrail that was damaged from a farmer over on Wenona Road is being repaired.

**Public Transportation:** Lueders reported all the contracts are completed and they should be receiving funds. The van that was hit a few months ago is fixed and back on the road.
