Resolution authorizing application for a Capital Assistance Grant for paratransit vehicle(s) under the Illinois Department of Transportation's general authority to make such Grants.

WHEREAS, The provision and improvement of public transportation and specialized transportation for seniors and individuals with disabilities is essential to the development of a safe, efficient, functional transportation system; and

WHEREAS, The Illinois Department of Transportation has the authority to make such Grants and makes paratransit vehicles available to private non-profits, general public transportation systems or IDOT Certified Public Provider transportation systems providing specialized paratransit service; and

WHEREAS, Grants for said assets will impose certain obligations upon the recipient.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BOARD OF MARSHALL COUNTY:


Section 1. That an application be made to the Office of Intermodal Project Implementation (OIPI), Department of Transportation, State of Illinois, for a financial assistance grant under the Illinois Department of Transportation's general authority to make such Grants, for the purpose of off-setting certain public transportation facility capital costs of Marshall County.


Section 2. That Gary Kroeschen of Marshall County is hereby authorized and directed to execute and file on behalf of Marshall County such application.

Section 3. That the Marshall County Board Chairman, Gary Kroeschen, of Marshall County is authorized to furnish such additional information as may be required by the Office of Intermodal Project Implementation in connection with the aforesaid application for said Grant.

Section 4. That Marshall County Board Chairman, Gary Kroeschen, of Marshall County is hereby authorized and directed to execute and file on behalf of Marshall County all required Grant Agreements with the Illinois Department of Transportation.

Hi Dave - I wanted to let you know I have had something come up & I will not be able to attend tomorrow's Board meeting. I wondered if you could relay to the Board the information that goes with the proposed Resolution.

Currently I am working on a grant called a CVP Capital grant which is for Marshall County to obtain replacement vehicles for our fleet. The vehicles we are applying for are 1 light duty with a lift and 2 minivans with ramps which will be replacing the same kind of vehicles we currently operate. There is no cost to Marshall County or MSW Projects for these vehicles as IDOT will be purchasing and awarding them. IDOT is predicting at least an 18 month wait after the grants have been reviewed before vehicles may be received by the grantees. The grant is due May 2nd and at this point I don't foresee it being late.

Thank you for relaying that information and apologize for not being able to attend the meeting.
