MARSHALL COUNTY BOARD MEETING October 13, 2022

The Marshall County Board met for the October Board meeting on October 13, 2022, at 8:30 A.M. Chairman Kroeschen called the meeting to order. Following the Pledge of Allegiance, roll call shows: Chairman Kroeschen, Lindstrom, Balensiefen, Stash, Minnick, Meierkord, McLaughlin, Gauwitz and Lueders were present.

Vice Chairman McGlasson, Donna and Bakewell were absent.

It was moved by Lindstrom and seconded by Balensiefen to **approve** the minutes as presented for September. Vote shows: all ayes, 0 nays, and 3 absent.

No Health Department update was given.

County Engineer Pat Sloan gave an update on Zoning. The next ZBA hearing will be on Thursday, October 20th at 7:00 pm. for solar in Bennington Township. The ZBA committee met and went over compliance issues and if the current situation is not cleaned up order of violation will be ordered and will start on December 1, 2022. A building permit was given to each member.

County Engineer Pat Sloan gave an update on Highway. He stated that construction work is completed. He put in for a new backhoe and the estimated delivery time is 6 months. He also stated that the foreman Dave Kenyon will be leaving from the County on November 30th. They are currently OK with personnel.

Zoning Administrator to hire Steve Tonioni. Steve will start October 24, 2022. He will have an office at the Highway Department and a laptop will be purchased. His salary will be \$65,000 and the amount will be split with Putnam County.
