
IT IS HEREBY ORDERED that the following holidays shall be observed by all courts in this State and by the Administrative Office of the Illinois Courts for the year 2024:

In addition to the foregoing holidays, the chief judge in each circuit in this State may declare a court holiday in any county in the circuit when the court facilities in that circuit or county are otherwise closed for the observance of a holiday not listed above. These additional observances shall be limited to only those situations in which both court security is unavailable and all county government offices are closed.

In the event the court facilities in a circuit or county are to remain open on one or more of the holidays, the chief circuit judge in which that situation occurs, may disregard the listed holiday and declare the court open on that day.

Hello again!

Some of you have questioned why there isn't an Election Day on the 2024 Supreme Court Holiday Schedule, similar to past Supreme Court Holiday Schedules.

In 2020, there was a Public Act declaring the General Election as a state holiday. However, it was not applied to all future General Elections. Therefore, if the chief judge has closed the courthouse on Election Day in 2024 it will need to be included in your holiday schedule listing. Tyler will send an email out later this year to get clerks to send in their schedules.

(10 ILCS 5/2A-1.1c new) 2022 Election Day State holiday.

Notwithstanding any other provision of State law to the contrary, November 8, 2022 shall be a State holiday known as 2022 General Election Day and shall be observed throughout the State. November 8, 2022 shall be deemed a legal school holiday for purposes of the School Code and State Universities Civil Service Act. Any school closed under this amendatory Act of the 102nd General Assembly and Section 24-2 of the School Code shall be made available to an election authority as a polling place for 2022 General Election Day.

This Section is repealed on January 1, 2023.

If any public acts pass declaring a state holiday, I will be sure to update you.
