MARSHALL COUNTY BOARD MEETING August 10, 2023

The Marshall County Board met for the August Board meeting on August 10, 2023; at 8:30 A.M. Chairman Kroeschen called the meeting to order. Following the Pledge of Allegiance, roll call shows: Gauwitz, Lindstrom, Chairman Kroeschen, McLaughlin, Minnick, Balensiefen, Meierkord, Lueders, Durham and Fecht present.

Vice Chairman McGlasson was absent.

It was moved by Balensiefen and seconded by Gauwitz to **approve** the July 13, 2023; minutes as presented. Vote shows: all ayes, 0 nays, and 1 absent.

No Health Department update was given.

Ryan Giacometti gave the update on Zoning. They had a special hearing on July 20th for a special use for Jesse's Wrecker Service and Storage Yard located at 501 County Rd 1900E in Varna. This will allow them to park 6 wrecked vehicles for up to 4 months on the property. The ZBA approved the special use. A list of building permits was handed out to each member. The next ZBA hearing is scheduled for August 17th for a variance for Midland School District CUSD #7 for a bus barn in Sparland on the west side of the fuel barrels.

Assistant County Engineer Catherine Terando gave an update on Highway. The maintainers have been working on site preparation and demolition of the existing buildings. Camp Grove Bridge replacement is almost completed. Snag Creek Bridge in Richland Township has received funds from the Illinois State Bridge Program. Seal Coating is starting up on the east side of the County. They are continuing to mow on the west side of the County.
