# MARSHALL COUNTY BOARD MEETING **December 14, 2023**

The Marshall County Board met for the December Board meeting on December 14, 2023; at 8:40 A.M. Chairperson Gauwitz called the meeting to order. Following the Pledge of Allegiance, roll call shows: Gauwitz, Vice-Chairperson McGlasson, Stash, McLaughlin, Minnick, Balensiefen, Lindstrom and Meierkord present. Durham and Fecht were absent.

It was moved by Balensiefen and seconded by Perona to **approve** the November 9, 2023; minutes as presented. Vote shows: all ayes, 0 nays, and 2 absent.

Health Department update: Hector Gomez was present. He stated they are seeing an increase in COVID and RSV at this time. It is recommended that people over 60 years of age, pregnant women and children get the vaccine as they are high risk. They have given 172 vaccines. Gomez stated that not every health department purchased the vaccine due to the cost. They are ordering the vaccines as they get the calls for people who want them. The cost is about \$186.00 per person. It is advised you must make an appointment.

## Zoning

Ryan Giacometti gave an update. They do not have any hearing scheduled for December. In November they had a hearing for a heliport for Ag Use for Norman Headings which will be in Bell Plain Township.

#### **Elevator:**

Ryan Tanzer from TKE was on the speaker phone and went over the proposal for a modernization for a new elevator. The current elevator was put in 1993. The life expectancy is about 20 years. The current one has had numerous issues, and they are working to try to get it fixed. After discussion it was decided that it is time to purchase a new one. With a new system you must have a fire/water system. PIPCO and Oberlander submitted quotes for the fire/water system and Oberlander will have the alarm system in case something was to happen. The total amount with the power unit added to the elevator is \$108,715.30.

#### **Highway**

Acting Engineer Catherine Terando gave an update. The maintainers are working on getting the equipment ready for winter. They sat through a few classes with IDOT on snow and ice control. The new building is coming along. She stated she has been in Springfield for the last 2 weeks. They are working with townships on road projects for next year. She has passed all her tests and will present the resolution in January!!

**EMA:** Koch reports the grant that they apply for each year to reimburse his salary he will only be receiving \$15,800 this next year. In 2023 he received \$21,000 reimbursement. The next meeting won't be until January 10<sup>th</sup>.

Finance/Budget: Chairperson Gauwitz reported the auditors were here this week.

**Human Resources & IT:** Lindstrom reported they are going to have a zoom call at 2:00PM, 3:00PM and 4:00PM to look at a new website.
