

## MARSHALL COUNTY HEALTH DEPARTMENT ENVIRONMENTAL HEALTH FEE SCHEDULE ORDINANCE

WHEREAS, the Marshall County Board of Health recommends adoption of the Environmental Health Department Fee Schedule attached hereto and incorporated herein.

NOW THEREFORE BE IT ORDAINED by Marshall County, Illinois, acting by and through the County Board that it adopts the Marshall County Health Department Environmental Health Fee Schedule attached hereto in accordance with the authority and provisions granted to the Marshall County Board and Marshall County Board of Health pursuant to Counties Code, 55 ILCS 5/5-25013.

**SECTION 1.** Title – This Ordinance shall be known as and may be cited as "The Marshall County Health Department Environmental Health Fee Schedule Ordinance".

**SECTION 2.** Conflicts – This Ordinance shall supersede all Marshall County and Marshall County Health Department Ordinances, Resolutions or parts thereof in conflict with the provisions of this Ordinance and said Fee Schedule.

SECTION 3. Effective Date – This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form with the Fee Schedule contained herein going into effect April 27, 2016.
