

# MARSHALL COUNTY BOARD MEETING

January 8, 2026

The Marshall County Board met for the January Board meeting on January 8<sup>th</sup>, 2026; at 8:30 A.M. Chairperson Travis McGlasson called the meeting to order. ## Health Department:

Hector Gomez was present. There has been an increase in influenza. Marshall County has increased by 21.8%. They still have the high dose vaccine for 65 and older.

## Zoning:

Ryan Giacometti gave an update. A ZBA hearing was held on December 18<sup>th</sup> for a Special Use Application by Prairie Violet Wind LLC to extend the Special Use Permit for the three existing MET Towers associated with the Old Town Wind Project. Machinley Taylor from Scout Clean Energy was present at the meeting.

## Highway:

County Engineer Catherine Terando gave an update. She stated that the maintainers have responded to the snow events and working on trimming brush and trees. The guard rail has been installed on Harvest Road Bridge. She has also been working with the road commissioners on upcoming projects.
